PETITION TO VACATE STREET

TO THE HONORABLE COUNCILMEN OF THE COMMON COUNCIL OF THE CITY OF ROCKPORT, INDIANA

The petitioners, Don F. Marsh and Molly Marsh, Mary Lee Montgomery Olson, and Mary Wayne Eble, respectfully represent and show to the Honorable Councilmen of the Common Council of the City of Rockport, as follows:

1. That the petitioners, Don F. Marsh and Molly Marsh, Mary Lee Montgomery Olson, and Mary Wayne Eble, are the owners of certain real estate in Rockport, Spencer County, Indiana, which real estate borders a portion of Seminary Street, which portion is not used as a street or public way, as more fully shown in the survey of George T. Wandel, dated October 29, 1991, a copy of which is attached as Exhibit "A" and by this reference made a part hereof. The relevant portion of Seminary Street is outlined in blue marker on Exhibit "A."

2. That the real estate owned by Don F. Marsh and Molly Marsh, which is more fully outlined in green marker on Exhibit "A," is occupied by a sewer main, lift station, and rock road, as more fully shown on Exhibit "A"; the occupation of the real estate of Don F. Marsh and Molly Marsh by such City of Rockport improvements were not granted subject to any easement.

3. That the petitioners desire to vacate that portion of Seminary Street more fully described in the legal description, attached hereto as Exhibit "B" and by this reference made a part hereof.

4. That, in the event the Honorable Councilmen of the Common Council of the City of Rockport grant such vacation of that portion of Seminary Street shown in Exhibit "B," the petitioners, Don F. Marsh and Molly Marsh, Mary Lee Montgomery Olson, and Mary Wayne Eble, propose to grant to the City of Rockport a twenty-five foot easement concerning the sewer improvements of the City of Rockport as more fully shown in Exhibit "A" and outlined in yellow marker on said Exhibit "A."

5. That the street the petitioners herein seek to vacate is not being used by the public and will not adversely affect the public interest.

6. That the only other owners of real estate that adjoin that portion of the street which petitioners seek to vacate are John A. Hargis and Connie L. Hargis, who shall be given due notice of this petition.

WHEREFORE, your petitioners respectfully pray the Honorable Councilmen to close and vacate the street as described in this petition.
