

**AN ORDINANCE SETTING USAGE AND RENTAL RATES OF  
PROPERTIES FALLING UNDER THE JURISDICTION OF THE PARKS  
BOARD FOR THE CITY OF ROCKPORT AND AMENDING  
ORDINANCE NO. 2015-8**

WHEREAS, the community building, shelter house, and city pool, all located within the Rockport City Park, are properties of the City of Rockport, and available for public use.

WHEREAS, the City of Rockport has authority to maintain and govern properties falling under the jurisdiction of its Parks Board and desires to set usage and rental rates for such properties; and

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Rockport, Indiana, as follows:

SECTION ONE. The community building shall be available for rental to the public at a flat rental charge of \$75.00 plus applicable taxes and fees. A refundable deposit of \$75.00 to be applied against any costs of clean up, damage or injury to any improvements, if alcohol is not available to guests. Renters desirous of serving alcohol will be charged a \$150.00 rental fee and a refundable deposit of \$100.00 to be applied against any costs of clean up, damage or injury to any improvements, and will be responsible for furnishing a valid Indiana liquor license, at least one licensed bartender, and a law enforcement officer.

SECTION TWO. The shelter house at the Rockport City Park shall be available for public rental at the flat rate of \$20.00 plus applicable taxes and fees. A refundable deposit of \$10.00 shall be charged, to be applied against any costs of clean up, damage or injury to any improvements.

SECTION THREE. The Rockport City Pool shall charge admission of \$3.00 per person, general admission, with an individual season pass available for \$60.00 per person and a family season pass available for \$125.00 per season.

SECTION FOUR. The Rockport City Pool shall be available for private rental during the hours of 6:00 p.m. to 8:00 p.m. on authorized days for fixed, non-refundable sum of \$150.00 plus applicable taxes and fees. A refundable deposit of \$50.00 shall be charged, to be applied against cost of clean up, damage or injury to any improvements, payable two (2) weeks in advance of the date requested.

SECTION FIVE. The restrooms in the concession stand located between the ball fields shall be available for use at no cost. A refundable deposit of \$100.00 shall be charged, to be applied against any costs of clean up, damage or injury to any improvements.

SECTION FIVE. This Ordinance shall be in full force and in effect from and after its passage and adoption by the Common Council of the City of Rockport and due publication in accordance with law.
