AN ORDINANCE AMENDING ORDINANCE NOS. 2020-5 AND 2021-1

WHEREAS, the Common Council previously established the salaries for the employees of the City of Rockport in Ordinance No. 2020-5; and

WHEREAS, the Ordinance No. 2020-5 was amended by Ordinance No. 2021-1 to include a provision for the water department superintendent, which position was subsequently created; and

WHEREAS, the Common Council has determined that all non-elected employees of the City of Rockport shall receive 2% raise, which raise shall be retroactive to January 1, 2021.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Rockport, Indiana, that Ordinance Nos. 2020-5 and 2021-1 shall be amended in part as follows:
