AN ORDINANCE TO VACATE AN ALLEY IN L.G. SMITH'S ADDITION IN THE CITY OF ROCKPORT STATE OF INDIANA

BE IT HEREBY ORDAINED by The Common Council of the City Of Rockport, Indiana, as follows, to-wit:

WHEREAS, heretofore a Petition To Vacate An Alley has been filed by all adjoining owners, to-wit:

MICHAEL J. WARGEL and DELLA M. WARGEL, MELVIN L. CHASE and FRANCES T. CHASE, ROBERT W. THOMAS and FLORENCE THOMAS,

each being an owner of property adjoining the following described alley, which said alley is more specifically described as follows:

Beginning at the Northeast corner of Lot 96 and extending along the North side of said Lot 96 and the North side of Lot 95, 250 feet, more or less, to the Northwest corner of said Lot 95; thence North 12 feet; thence East along the South side of Lots 102, 101, 100, 99, 98, and 97 for 250 feet to the Southeast corner of said Lot 97; thence South 12 feet to the place of beginning.

Beginning at the Northeast corner of Lot 96 and extending along the North side of said Lot 96 and the North side of Lot 95, 250 feet, more or less, to the Northwest corner of said Lot 95; thence North 12 feet; thence East along the South side of Lots 102, 101, 100, 99, 98, and 97 for 250 feet to the Southeast corner of said Lot 97; thence South 12 feet to the place of beginning.

be, and the same hereby is Vacated and each adjoining owner shall be the owner of an additional six feet of the vacated alley, all as by law provided.

THIS ORDINANCE shall be in full force and effect from and after its passage by the Common Council, its approval by the Mayor and its publication as required by law, which publication is now Ordered.


