

RESOLUTION NO.2006- 9

**A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF ROCKPORT, INDIANA, AUTHORIZING THE PARKS BOARD TO TRANSFER CERTAIN FUNDS TO CAPITAL OUTLAYS TO BE ENCUMBERED FOR CERTAIN EXPENSES FOR CALENDAR YEAR 2007**

WHEREAS, the Common Council for the City of Rockport has the ability to allow the Rockport Parks Board to transfer funds from certain itemized accounts to Capital Outlays to be used for various Parks Board expenses; and

WHEREAS, the Common Council has determined that it is in the best interest of the citizens of the City of Rockport that a total Fifteen Thousand (\$15,000.00) Dollars should be transferred from Personal Services, Supplies, and Other Services and Charges to Capital Outlays to be encumbered to pay for road repairs in calendar year 2007.


NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF ROCKPORT, INDIANA, AS FOLLOWS:

1. The Parks Board for the City of Rockport shall be authorized to transfer a total of Fifteen Thousand (\$15,000.00) Dollars from Personal Services, Supplies, and Other Services and Charges to Capital Outlays.


2. Said amount shall be encumbered during calendar year 2007 to pay for road repairs and any other expenses deemed necessary for the betterment of the grounds under the care and supervision of the Parks Board for the City of Rockport.

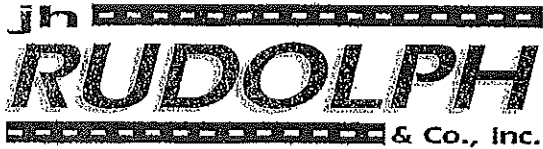

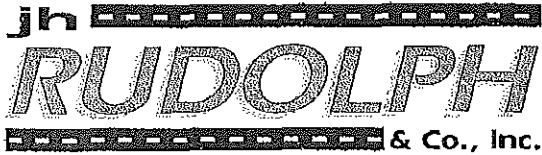

As per your request, I have estimated the cost to overlay the North half of the existing loop road at the city park. Please review the following and call me at (812) 937-3715, ext. 220 should you have any questions.

Overlaying North half of Loop Road with Hot Mix Asphalt

1. We will mill down the existing asphalt speed bumps and at all stop and start locations.
2. We will sweep clean all areas of paving.
3. We will furnish and apply a liquid asphalt tack coat.
4. We will pave over the 10 foot wide roadway (2,385 square yards total) with an average 1-3/4 inches of #11 Hot Mix Asphalt Surface.

**For the sum of \$16,100.00**

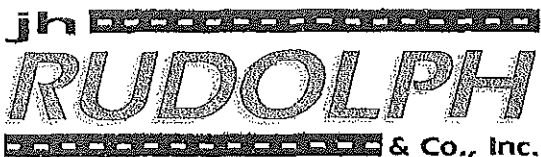

As per your request, I have estimated the cost to pave a wedge and level course over the existing loop road and to pave the maintenance building road at the city park. Please review the following and call me at (812) 937-3715, ext. 220 should you have any questions.

Price No. 1: Loop Road Paving with Hot Mix Asphalt

1. We will sweep clean all areas of paving.
2. We will furnish and apply a liquid asphalt tack coat.
3. We will pave a wedge and level course over 1,050 square yards of badly deteriorated areas with an average 1-1/2 inches of #11 Hot Mix Asphalt Surface.

**For the sum of \$10,104.00**

Price No. 2: Maintenance Building Road Paving with Hot Mix Asphalt

1. We will sweep clean all areas of paving and grade the existing stone base section.
2. We will furnish and apply a liquid asphalt tack coat.
3. We will pave the 10 foot wide road (320 square yards total) with 2 inches of #11 Hot Mix Asphalt Surface.

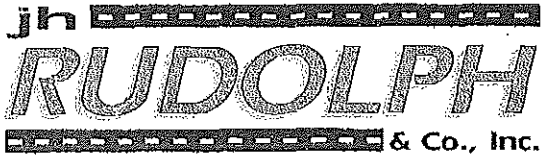

As per your request, I have estimated the cost to pave or apply chip and seal courses over the existing parking lot at the Community Building. Please review the following and call me at (812) 937-3715, ext. 220 should you have any questions.

Base Bid: Community Building Parking Lot with Hot Mix Asphalt

1. We will completely mill up and scarify the existing broken asphalt pavement.
  2. We will add and grade in 3 inches of new crushed limestone; and compact to proper density.
  3. We will pave over the prepared base with 2-1/2 inches (one layer) of #9 Hot Mix Asphalt Surface.
- For the sum of \$31,390.00**

Alternate Bid: Community Building Parking Lot with Double Chip and Seal

1. We will completely mill up and scarify the existing broken asphalt pavement.
  2. We will add and grade in 3 inches of new crushed limestone; and compact to proper density.
  3. We will furnish and apply a liquid asphalt prime coat over the prepared stone base at the rate of 0.40 gallons per square yard.
  4. We will furnish and apply a liquid asphalt seal coat at the rate of 0.35 gallons per square yards followed by a layer of #11 crushed stone chips, two courses each giving a double chip and seal pavement.
