

**AN ORDINANCE OF THE CITY OF ROCKPORT, INDIANA FOR THE
ESTABLISHMENT AND APPROPRIATION OF A FUND FOR
IMPROVEMENTS TO SUNSET HILL CEMETERY**

WHEREAS, the Common Council of the City of Rockport, pursuant to Order Terminating Trust entered In Re: The Testamentary Trust of Helen V. Young, Deceased, Spencer Circuit Court, Cause No. 74C01-0901-TR-0003, has received from Old National Trust Company the sum of \$56,365.70;

WHEREAS, the Spencer Circuit Court has ordered that the funds received shall be used to refurbish the shelter house at Sunset Hill Cemetery, for the benefit of the public and for the naming of the shelter in honor of Helen V. Young, with a suitable plaque placed in a conspicuous location for the public to be informed of the benefit bestowed upon the shelter house by Helen V. Young; and

WHEREAS, the Common Council desires to establish a separate fund for such monies and to provide for its appropriation for the uses ordered by the Spencer Circuit Court.

NOW, THEREFORE, BE IT ORDINATED BY THE COMMON COUNCIL OF THE CITY OF ROCKPORT, INDIANA, AS FOLLOWS:


SECTION 1. There is hereby established a fund, being 217 Donation, Revenue 217499 Donation/Other, to be commonly known as the "Helen V. Young Cemetery Account" to be administered in accordance with the appropriation hereinafter provided.


SECTION 2. The Common Council does hereby appropriate the fund commonly known as the "Helen V. Young Cemetery Account," appropriation number 217950361 (donation/other/repairs and maintenance), for the use and expenditure of funds to accomplish the refurbishment of the shelter house, for the benefit of the public and its use of the Sunset Hill Cemetery and for the naming of the shelter house in honor of Helen V. Young, with a suitable plaque placed at a conspicuous location for the public to be informed of the benefit bestowed upon the shelter house by Helen V. Young.

SECTION 3. The City of Rockport is hereby authorized to accept additional monetary gifts into the fund commonly known as the "Helen V. Young Cemetery Account," which fund shall be used and appropriated for the purposes as hereinbefore established by this ordinance.


ADOPTED this 1st day of June, 2009. This ordinance shall be in full force and effect upon and after its passage and approval in accordance with law.




