

ORDINANCE NO. 2012-4

**AN ORDINANCE AMENDING ORDINANCES 2000-1, 2000-3, 2006-13 AND 2010-9 BY RE-DEDICATING MONIES FROM PLEDGED AEP FUNDS AND AEP RENEWAL FUNDS TO VARIOUS CITY OF ROKPORT FUNDS**

WHEREAS, the City of Rockport has been receiving annual payments from AEP under Ordinances 2000-1, 2000-3, 2006-13 and 2010-9; and

WHEREAS, the City of Rockport now receives \$300,000 per year from AEP Funds and AEP Renewal Funds, beginning November 1, 2008 and including November 1, 2012; and the City of Rockport now determines that it is in the best interest of Rockport and its citizens to reallocate said AEP Funds and AEP Renewal Funds in separate amounts to the following funds: William Natcher Bridge, Motor Vehicle Highway, Park and Recreation, Lincoln Pioneer Village, General, and AEP Capital; and

WHEREAS, the City of Rockport, by its Mayor, has obtained the consent of AEP to allocate and utilize the AEP Funds and AEP Renewal Funds payable on or about November 1, 2012 as hereinafter provided.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Rockport that Ordinances No. 2000-1, 2000-3, 2006-13 and 2010-9 are hereby amended as follows:

**SECTION ONE:** On or about November 1, 2012, and for the year 2012, a total of \$75,000.00 out of the AEP Funds and/or AEP Renewal Funds shall be transferred to the William Natcher Bridge Fund (404).

**SECTION TWO:** On or about November 1, 2012, and for the subsequent year, 2013, a total of \$10,000.00 out of the AEP Funds and/or AEP Renewal Funds shall be transferred to the Motor Vehicle Highway Fund (201).

**SECTION THREE:** On or about November 1, 2012, and for the subsequent year, 2013, a total of \$15,000.00 out of the AEP Funds and/or AEP Renewal Funds shall be transferred to the Park and Recreation Fund (204).

**SECTION FOUR:** On or about November 1, 2012, and for the subsequent year, 2013, a total of \$20,000.00 out of the AEP Funds and/or the AEP Renewal Funds shall be transferred to the Lincoln Pioneer Village Fund (231).

**SECTION FIVE:** On or about November 1, 2012, and for the subsequent year, 2013, a total of \$50,000.00 out of the AEP Funds and/or AEP Renewal Funds shall be transferred to the General Fund (101).


**SECTION SIX:** On or about November 1, 2012, and for the subsequent year, 2013, a total of \$130,000.00 out of the AEP Funds and/or AEP Renewal Funds shall be transferred to the AEP Capital Fund (473).


SECTION SEVEN: All ordinances and parts of ordinances in conflict therewith are hereby repealed; however, this ordinance shall not be construed as amending or repealing the ordinance provisions authorizing the bonds referred to in ordinances 2000-1, 2000-3, 2006-13 and 2010-9. Said ordinances shall remain in full force and effect in all other aspects.


SECTION EIGHT: This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.







**ORDINANCE / RESOLUTION FOR APPROPRIATIONS AND TAX RATE**

Ordinance / Resolution Number: 2012-5

Be it ordained / resolved by the **Common Council** that for the expenses of **ROCKPORT CIVIL CITY**, Indiana for the year ending December 31, **2013** the sum of **\$907,333** as shown on Budget Form 4-A are hereby appropriated and ordered set apart out of the funds herein named and for the purposes herein specified, subject to the laws governing the same. Such sums herein appropriated shall be held to include all expenditures authorized to be made during the year, unless otherwise expressly stipulated and provided for by law. In addition, for the purposes of raising revenue to meet the necessary expense of **ROCKPORT CIVIL CITY**, a total property tax levy of **\$290,139** and a total tax rate of **0.8878**, are adopted as shown on Budget Form 4-B and included herein. Budget Form 4-A and 4-B for all funds and departments are incorporated by the signing of this form and must be completed and submitted in the manner prescribed by the Department of Local Government Finance.

This ordinance / resolution shall be in full force and effect from and after its passage and approval by the taxing **Common Council**.
