

ORDINANCE NO. 2023- 3

AN ORDINANCE
AMENDING ORDINANCE NOS. 2022-8 and 2023-1

WHEREAS, the Common Council previously established the salaries for the employees of the City of Rockport in Ordinance No. 2022-8; and

WHEREAS, Ordinance No. 2022-8 was amended by Ordinance No. 2023-1 to reflect that employee Kam Cron did not qualify for the lump sum merit bonus; and

WHEREAS, the Common Council deems it necessary to include as part of the salary ordinance the position of Executive Director Of Indiana Main Street Program at the rate of \$500.00 bi-weekly.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Rockport, Indiana, that Ordinance Nos. 2022-8 and 2023-1 shall be amended in part as follows:

SECTION ONE: The following amendment of the salaries and wages are hereby fixed and adopted for the following appointed officers and employees of the City of Rockport payable out of the respective funds of said party effective January 1, 2023.



EXECUTIVE DIRECTOR OF INDIANA MAIN STREET PROGRAM	\$	500.00 BI-WEEKLY


SECTION TWO: All other provisions of Ordinance Nos. 2022-8, 2023-1 shall remain in full force and effect.


SECTION THREE: This Ordinance shall be in full force and effect upon passage.






